

## **SUMMARY OF CHANGES IFA V5.1 TO V5.2**

### **1. BACKGROUND TO THE VERSION UPDATE**

The main reason for issuing an update of the IFA Standard are changes necessary for Global Food Safety Initiative (GFSI) recognition as well as general clarification and improvements.

Furthermore, we took this opportunity to make orthographical adjustments and minor layout changes where necessary. These adjustments and changes will not be listed in the description of modifications when they do not affect the meaning of the text.
